





Vehicle Club COVID-Safe Guidelines

Thanks to the generous sponsorship of Shannon's Insurance – insurance for the motoring enthusiast, and the Bay to Birdwood – one of the world's great historic motoring events, the History Trust of South Australia welcomes your club to the home of Australia's biggest motoring collection, the National Motor Museum.

To ensure the safety of all visitors, team members, and the wider South Australian community, a number of COVID-19 safety precautions have been implemented at the museum. These are guided by expert health advice and in accordance with the South Australian and Australian Government requirements.

In accordance with the National Motor Museum's COVIDSafe Plan and COVID-19 response processes, please note the following:

State Legislation requires that contact tracing details (name and phone number OR email address) are collected from all visitors to the museum. Information collected for Contact Tracing will only be used by SA Health.

Attendance is not permitted for any person or persons who:

- Are feeling unwell or experiencing COVID-19 like symptoms (fever or chills; cough or shortness of breath; loss of taste or smell; unknown respiratory symptoms)
- Are awaiting results of a COVID test
- Are under instruction to self-isolate or quarantine
- Have visited a declared hotspot, as identified by SA Health, within the relevant period

When attending the National Motor Museum site, the following guidelines must be followed by all attendees:

- Observe and maintain physical distancing (at least 1.5m) from all persons outside the group you arrived with
- Avoid physical greetings such as handshaking, hugs and kisses
- Practice regular hand hygiene there are numerous sanitiser stations throughout the pavilions
- Practice good sneeze and cough hygiene
- Observe the safety signage throughout the site
- Follow the directions from team members
- Observe pathway and queue markers where applicable
- Use the bins provided for the disposal of rubbish

Please also note the following:

- BYO food (non-shared or buffet) is permitted on site, pending the current COVID-19 restrictions
- Caterers with a COVIDSafe Plan are permitted
- QR code sign-in for contact-tracing is required
- Patrons must be prepared to comply with all mask-wearing requirements while on site. We strongly
 encourage visitors to bring their own reusable masks. Please see our front desk upon arrival for the most up
 to date advice and requirements.

We encourage Club members to download and activate these apps prior to your visit to make check in quicker: mySA GOV, and COVIDSafe.
